An Act respecting the University of Windsor

WHEREAS the University of Windsor by its petition Preamble has prayed for special legislation in respect of the matters hereinafter set forth; and whereas it is expedient to grant the prayer of the petition;

Therefore, Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Ontario, enacts as follows:

- 1. Section 5 of The University of Windsor Act, 1962-63 is 1962-63, amended by striking out "but such management and control amended shall be based upon Christian principles", in the fifth and sixth lines so that the section shall read as follows:
- 5. The management and control of the University Board shall be vested in a non-denominational board of nominational governors, and no religious test shall be required of any professor, lecturer, teacher, officer, employee, servant or student of the University.

and on the expiry of the initial term of any such member. the vacancy shall be filled in the manner prescribed and the successor shall serve a term of three years and thereafter from time to time, provided that any such member who ceases to be a member of the teaching staff shall forthwith cease to be a member of the Board.
