Faculty Publications page: Faculty of Law Publications | Faculty of Law (uwindsor.ca). This page was two years out of date as of May 2024. I took the initiative to gather up all information from Mita's feed, as well as from individual faculty webpages, created proper legal citations, proper links and abstracts for content from 2022 to present to ensure that highlighting faculty publications on the law school website continues to be a priority.

Law Library Communications Plan: I updated the plan, which has been in existence for the past ten years, proposing updates to it. I also proposed the addition of a Featured Library Guide on the homepage of the law library to showcase our help guides.

Thomson Reuters 3-year deal: I handled all communications with our print and electronic resources representatives at Thomson Reuters (TR), prepared a spreadsheet that provided detailed information about product costs, usage, faculty requirements, etc., for decisioning by the law librarians. I negotiated a fair price for the adoption of our next three-year contract for the Topical Texts and Annotations (TTA) collection which resulted in our doubling of TR content.

I also prepared documentation for a comprehensive review of all print standing orders through Thomson Reuters, decisioned by the librarians which resulted in cost savings of \$13, 623.

Transnational Criminal Law Review: I handled all aspects of disseminating a new law journal to a variety of indexes and full-text databases around the world. I advised them on the platform and policies to use to launch the product.

Bail repository: I created a <u>website</u> to house all advocacy by Professor Jones in his quest for fairness in Canada's bail process. I have also advised him on several occasions about a quantitative research project he has undertaken.

Rare Documentary: I located a copy of a rare documentary. I also provided significant support to the Research Assistant working on historically racist BC legislation to aid. These supports were provided to assist in setting up the *Asians and the Law* course.

German Works: I assisted a faculty member in locating a variety of rare German historical works and in translating these to English.

Foreign Laws: I assisted a faculty member in locating a variety of Azerbaijani, Andorran, Burkinabe, Dutch, Ghanian, Nicaraguan and South African legislation.

Al Assistance for Faculty and Students: I created a video and resource list designed to help faculty members see how students may use generative AI to draft a law school essay.

I created a <u>Guide to Artificial Intelligence Regulation</u> and a <u>Guide to Artificial Intelligence</u> <u>Resources</u>, which included draft guidance for students.

I now disseminate a regular AI Newsletter to interested faculty members.

Indigenous Pre-Law Program - I created an innovative introduction to the common law system

and to legal research generally and presented it at the Indigenous Pre Law Program in August of 2023. I have been invited to present again in 2024.

Law Library Classes – the program above was repurposed into a session for first year law students as well.

Scholarly Impact: I created scholarly impact scans for three faculty members.

Guest Speaker: I was a guest speaker in Professor Keller's Business Agreements class, in Professor Wharton's International Law and International Criminal Law classes, and in Professor Senthe's Sport Law class.

Contract Negotiation: I assisted a campus administrator in negotiating a contract with Westlaw.

Innovating Law Journals: I recommended AI and other enhancements for author submission guidelines for local law journals.

Off-site Access: In August of 2023, many of the law library's subscription products were offline, and had been for several months. I spent hours updating the ex-proxy configuration file which was very out of date to bring all products back online.
