**Program Update** 

Healthcare systems and the roles and responsibilities of registered nurses (RNs) who work within these systems are rapidly evolving. The design and delivery of master's nursing programs must adapt to meet the current and future competencies required of RNs in current and future direct and indirect advanced nursing roles in this system (Canadian Association of Schools of Nursing [CASN], 2015).

To address these needs, the Faculty of Nursing undertook a major redesign of our master's programs. The revised program outcomes and courses were approved by the University of Windsor Senate in spring 2023, and are launching this Fall, 2024.

**Primary Health Care Nurse Practitioner Programs** 

The Master of Science in Nursing Primary Health Care Nurse Practitioner (MScN/PHC-NP) Program is a collaborative **course-based** consortium degree program. Students will be prepared to provide collaborative and autonomous primary health care to individuals, groups or communities, emphasizing health promotion and illness/ injury prevention. Students will develop advanced assessment, diagnostic and clinical reasoning skills in preparation for ordering and interpreting diagnostic tests, communicating diagnoses, prescribing pharmaceuticals, and performing other specific controlled procedures.

## **Essential Academic Requirements**

- Must have a Bachelor of Science in Nursing or equivalent nursing degree (eg. BN, etc.) with a minimum 70% average in the last two years of their undergraduate program.
- Must have current registration with the College of Nurses of Ontario with no practice restrictions.
- Equivalent of two years of direct nursing (RN) experience in the last five years (>3,640 hours) which must be completed by the application submission deadline.
- Preference will be given to Ontario residents.

Program Intake: Annually each September Application Deadline: February 1st

Mode of Instruction: In Class/online/clinical placements

**Placement Locations:** Must complete clinical placements within the following locations: Windsor and the greater Windsor area, which encompasses Essex County, Chatham-Kent County and Lambton County (Sarnia region) only (See map on page 10)

Program Length: Two years full-time or three years part-time




**Nurse Practitioner Program Clinical Expectations** 

During your time in the MScN/PHC-NP program here at the University of Windsor, you will have clinical placement within the **University of Windsor NP catchment area** (see map). It is your

responsibility to ensure you have transportation to your clinical placements. Students at the University of Windsor **will not** contact nurse practitioner preceptors to find their own placements. The NP program placement coordinator will assign you to a clinical placement that best meets your needs to be successful in the program. This will ensure that you are as prepared as possible for this exciting new career as an NP in Canada or the United States.

During clinical placement students will follow their preceptors' clinical schedule to acquire the



required clinical hours (see hours below). Every attempt will be made to ensure that all students get as many face-to-face clinical hours as possible.

Program continuation is contingent upon appropriate ethical behavior and personal suitability for clinical work according to criteria and procedures developed for program. Students are expected to take responsibility for meeting all Faculty of Nursing clinical placement policy requirements and for conforming to any additional agency-specific policies. Students will be denied access to a clinical placement site if they fail to be cleared for clinical placement including site specific orientation and vaccination requirements. The Faculty of Nursing is not responsible for providing an alternative clinical experience for students who do not meet the requirements. It is recommended that full-time students complete the program within three consecutive calendar years after the student's first registration. Full-time students will pay full-time fees even if taking only one course in a semester. Nurse Practitioners must register their plan through the Ontario Primary Health Care Nurse Practitioner (CRDB) website and register for the courses at the University of Windsor through UWinsite student.

All master's students will have a faculty academic advisor assigned in the fall of their first year.

The faculty advisor will:

• Guide the student with course selection and plan for degree completion.

- Counsel the student on changes to the course plan.
- Provide the student with an appraisal of progress.
- Engage in preliminary discussions with the student about a thesis topic.

The Faculty Advisor may transition to become the student's thesis supervisor or support the student in finding an appropriate supervisor. The student will include the Associate Dean and Faculty Advisor (if appropriate) in discussions related to supervisor selection/change.

Orientation will be held in person over two days (September 5<sup>th</sup> & 6<sup>th</sup> 2024), and your attendance and participation are required. You are responsible for arranging your own accommodations if you are travelling and plan to stay overnight.

## **Expectations of Graduate Students**

### **Graduate Student Professionalism Expectations**

Students of the Faculty of Nursing are expected to adhere to all College of Nurses of Ontario practice standards, with emphasis on the revised CNO Code of Conduct (2023), in all interactions with peers, community partners, faculty, and staff. Failure of any nursing student to conform to the principles of these documents may result in dismissal from any of the Faculty of Nursing programs at the University of Windsor.

### **Graduate Student Academic Integrity Expectations**

Definition of Plagiarism: "the act of copying, reproducing or paraphrasing portions of someone else's published or unpublished material (from any source, including the internet), without proper acknowledgement. Plagiarism applies to all intellectual endeavours: creation and presentation of music, drawings, designs, dance, photography and other artistic and technical works. In the case of oral presentations, the use of material that is not one's own, without proper acknowledgment or attribution, constitutes plagiarism and, hence, academic dishonesty. (Students have the responsibility to learn and use the conventions of documentation as accepted in their area of study.)"(Student Code of Conduct)

The University of Windsor Faculty of Nursing highly values student demonstration of intellectual honesty that is integral to academic integrity (Senate Bylaw 31 Academic Integrity, n.d.; Graduate Studies Policy on Plagiarism ([GSSP], n.d.). Academic integrity links to the Faculty of Nursing Mission and Vision (through emphasis on scholarship) and embodies faculty values (professionalism and respect). All students enrolled in all University of Windsor Faculty of Nursing graduate programs are expected to review and adhere to Bylaw 31: <u>Academic Integrity</u>, the <u>Graduate Studies Policy on Plagiarism</u> and <u>Senate Policy on Authorship</u>. Academic integrity learning resources are available through the Office of Academic Integrity.

Further, "It is not permissible for an essay or other paper to be submitted twice. It is expected that a thesis, essay, paper or report has not been, and is not concurrently being, submitted to any other Faculty or University for credit toward any degree, or to this University for any other course" (GSPP, para 5, n.d.).

### **Use of Plagiarism-Detection Software**

The University believes in the right of all students to be part of a university community where academic integrity is expected, maintained, enforced, and safeguarded; it expects that all

students will be evaluated and graded on their own individual work; it recognizes that students often use the ideas of others as expressed in written, published, or unpublished work in the preparation of essays, assignments, reports, theses, and publications. However, it expects that both the data and ideas obtained from any and all published or unpublished material will be properly acknowledged, and sources disclosed. Failure to follow this practice constitutes plagiarism. This is important because anyone demonstrating dishonesty, cheating, or plagiarism in relation to any aspect of courses offered in the Faculty of Nursing graduate programs will receive a failing grade. The University, through the availability of plagiarism- detection software, desires to encourage responsible student behaviour, prevent plagiarism, improve student learning, and ensure greater accountability (<u>Senate Policy on Plagiarism</u> <u>Detection Software, Appendix A</u>)

#### Use of Generative Artificial Intelligence (AI)

Generative AI is technology that creates human-like content – including text, images, video and computer code – by identifying pattens in large quantities of training data, and then creates original material that has similar characteristics. Examples include: ChatGPT, Google Gemini, Claude, and Jenni, which can generate text, Github Co- pilot, which can generate coding and programming, and DALL-E and Midjourney, which can generate images. (Pasick, 2023.

Senate Bylaw 55 requires that instructors include on their course syllabus "information or restrictions regarding the use of generative artificial intelligence (AI) in the course." The default for not including the information in the course syllabus is that use of generative AI is permitted in the course (Senate: May 10, 2024).

Your course instructors will decide whether generative AI is permitted in their classes. If permitted, they will define the permitted uses, and information about use will be included in all course outlines. There may be different permitted uses across various courses in the MScN program, so please carefully make note of what is permitted in each course and contact your instructor if you have questions about interpretation of the statements in course outlines. Failure to abide by course-specific generative AI policies will be considered academic misconduct and may be subject to discipline under <u>Bylaw 31: Academic Integrity</u>

#### Instructional and Evaluation Methods

During your graduate studies you can expect to engage in a variety of different instructional and evaluation methods to meet the learning outcomes of courses in which you are registered. Some examples of diverse instructional methods include but are not limited to individual work, work in pairs and/or teams, synchronous and/or asynchronous online class work, face-to-face class work, work outside of class, in-class work, readings assigned in advance of class, student presentations, student seminar facilitation, and boot camps held outside of regular class hours.

These instructional methods often include activities requiring active class participation. Some examples of diverse evaluation methods include but are not limited to instructor graded written assignments (paper, annotated bibliography, professional quality assurance report), take home assignments, in-class tests, take home exams, graded presentations, and graded seminar facilitation. Some evaluation methods also include a peer evaluation component.

The outlined instructional methods are likely significantly different than those you have experienced in your previous university education. You are responsible for your own learning. Specifically, graduate students in the Faculty of Nursing are expected to thoroughly prepare in advance of classes and actively participate during classes.

Workload for graduate courses typically 2 to 3 hours per credit hour for both online and in person classes. This equates to 6 to 9 hours per week for a 3-credit course that you can expect to devote to advance class preparation and course assignments. - Course class attendance is the expectation. Out of respect for your professor and classmates, please notify your professor in advance if there is a class that you are unable to attend.
- Course assignments may be submitted to a plagiarism detection software program (e.g., Turnitin).
- No supplemental examination or assignments will be offered.
- Faculty of Nursing policy prevails for assignments submitted past deadline without approval (5 percent deduction per day).
