#### 5.1 Timing Guidelines for Online Exams

**5.2** Liberal Arts and Professional Studies (Aeronautics Leadership) Admission Requirements (Revision) (See document APC200318-5.2 for more details.)

MOTION: That the proposed revisions to the admission requirements for the Bachelor of Arts (Honours) in Liberal Arts and Professional Studies (LAPS) – Aeronautics Leadership be approved.

#### NOTED:

- Currently the program admits 40 qualified students on a first-come-first serve basis. Normally, there are approximately 150 applicants.
- In addition, students who are admitted often do not have their Transport Canada medical certificate or aviation language proficiency which delays their progress in the program.
- The new criteria to have students submit a supplementary application form with an essay will provide insight and background information about the applicant to ensure that they are suitable for the program.
- By requiring the Transport Canada medical certificate as part of the admission package, the University
  will be able to identify students ahead of time who might have a medical issue that will keep them from
  flying.

**5.3** Policy on Undergraduate English Language Proficiency Requirement - Revision (See document APC200318-5.3 for more details.)

- Due to the recent closure of testing centres in China, as a result of the coronavirus (COVID-19), the proposed revision will allow students to take language proficiency tests using an online method called the Duolingo English Test (DET) in place of the TOEFL and IELTS.
- In response to a question raised regarding whether this policy change will be revisited once the emergency response in lifted, it was noted that all policy and bylaws approved during this the COVID-19 period will come back for review, if the intent is that they continue beyond the COVID-19 period. This should be clarified in the motion.
