Senators were informed that the structure of the concurrent program has presented significant challenges for students, particularly in terms of degree completion within a tight 3-year timeframe, necessitating course overloads. The revised program will allow students to fallback to three-year Modern Languages program concurrently with Education with an option to return for an additional year to complete the honours degree. It also places a stronger emphasis on second language acquisition which better prepares teachers to engage with the diverse student population found in today's classrooms.

A question was raised about whether three-year degrees not adequately preparing teachers. In response, it was expressed that such concurrent programs do adequately prepare students for teaching in the classroom. It was also noted that there are numerous opportunities for teachers to enhance and upgrade their skills through continuing education, additional qualifications, graduate degrees, *etc*. The incentive for completing a four-year degree and continuing education in teaching is strong as it is tied to compensation.

5.3 Senate Governance Committee

5.3.1 Report of the Review Committee on Employment Equity (RCEE) Report (See documents S240510-5.2.2 for more details.)

Members were provided with a brief overview of the various initiatives and activities of the Review Committee on Employment Equity from August 2022 to September 2023. It was noted that the activities centered on: 1) analyzing and acquiring data; 2) enhancing equity campus wide; and 3) enhancing the equity infrastructure of the University. It was noted that the Diversity and Equity Assessment and Planning (DEAP) Tool continues to be used in hiring and throughout the appointments process.

Members agreed that ongoing efforts are needed to ensure formal and appropriate acknowledgement of the service contributions of Equity Assessors. It was suggested that this recognition should be included in RTP criteria that is reviewed annually.

The inclusion of language in the Course Syllabi will inform students about whether and how generative Artificial Intelligence (AI) may be utilized in coursework and assignments. It was suggested that this statement be mirrored in Senate Bylaw 55, for graduate students.

FRIENDLY AMENDMENT: That the following be added to Senate Bylaw 55, new paragraph between 1.1.7 and 1.1.8: *"Information or restrictions regarding the use of generative artificial intelligence (AI) in the course".*

Members noted that the default for not including the information in the course syllabus is that use of generative AI is permitted in the course. It was agreed that changing this to a default that its use would not permitted would not be appropriate or fair to students given that generative AI is ubiquitous (eg, prompts when sending phone texts for how to complete the text message) and students (as well as faculty and staff) may be unaware that they are using it.
