5.2 Proposed Revisions to Bylaws 2 and 3

MOTION 1: That the proposed revisions to Bylaw 2 be approved.

NOTED:

- The proposal formalizes the provisions for virtual or hybrid Senate Committee meetings.

AGREED:

- Requiring cameras to be on is not be enforceable, but encouraging members participating virtually to keep their video camera on, as much as possible, should continue to be emphasized.
- Continued and enhanced efforts are needed to provide the best experience (technology and governance) for members participating in meetings virtually.
- Further revisions to this and other bylaws and policies will be required once the new AODA regulations come into effect.

FRIENDLY AMENDMENT: That the first and third bullet be amended as follows:

- Meetings of the Committees of Senate shall be held 100% in-person unless there is a majority vote at the **beginning of the academic year** of the committee.
- Members participating virtually are encouraged to keep their video camera on, as much as possible, ~~for the entirety of the meeting to confirm presence to promote engagement.~~
