5.1 Report of the Review Committee on Employment Equity (RCEE) 2022-2023

- A comprehensive overview was provided on the 2022-2023 report of the Review Committee on Employment Equity (RCEE).
- The 2016 Canadian Census data for employment equity was used for this report due to the unavailability of the 2021 data.
- To emphasize its importance, service should be incorporated into job postings in a meaningful way.

AGREED:

 Members recognized the work that Equity Assessors (EAs) are providing in the institution and supported a focus on providing additional training and recognition for their work. Service as a whole,

- including EA service, should be enforced as an element of RTP.
- Hiring practices adopted for the Black Scholars Hiring Initiative should be reviewed with a view to incorporating successful elements into hiring policies and bylaws.
- Minor corrections were noted.

• A comprehensive overview of the work of the Research Ethics Board was provided, including its mandate, new initiatives, and challenges.
