## 5.1 Bylaw 31 – Revisions

# **5.2 Proposed Revision to Bylaw 51 – Multiple Exams Clause** (See document SGCa181120-5.2)

# MOTION: That the proposed revision to Bylaw 51 be approved.

NOTED:

- In response to a question raised, it was clarified that mid-term denotes a major test in the middle of the term; however, not all courses are structured that way. "In-term" is broader in scope.
- It was noted that the new exam scheduling system will not tell students what exam conflicts they have upon registration. Instead, the new system will use math optimization software to schedule exams once the add/drop period is over. It is expected that the new system will reduce conflicts significantly.

# 5.3 Bylaw 51 – Revisions

## NOTED:

- Beginning next semester, exams will be managed by INFOSILEM, a mathematical optimization software. This system is designed to reduce conflicts for multiple exams in the exam period.
- The schedule will be generated following the end of the add/drop period. In 12-week semesters, this will allow students two weeks to request an alternate exam.

## MOTION: That the proposed revisions to Bylaw 1 be approved.

NOTED:

- The question of being removed from Senate and not having the opportunity to represent their AAU was raised. In response, it was noted that not all AAUs are represented on Senate.
- Missing three consecutive meetings translates into three months of missed Senate meetings, which represents a full semester of meetings if in the Fall.
- Concern was raised regarding managing the process in terms of personal/private information that would be available to the Senate Governance Committee. Would it be in the form of a doctor's note and how much detail would be required? If an exception is made and the individual misses the next meeting, how would this be managed?
- The question of running Senate efficiently was also raised as a concern.

AGREED:

- Members upheld the original clause, noting that this provision is about ensuring that Senate is
  making decisions based on the perspectives of all representative groups. Missing three consecutive
  meetings, regardless of the reasons, means that the perspective of the representative group is not
  being provided fully.
- That it be reported to Senate that the Senate Governance Committee decided to uphold the original rationale and leave the clause as is.

## 5.5 Bylaw 40 and Bylaw 20 – Revisions

## MOTION: That the proposed revisions to Bylaw 40 and Bylaw 20 be approved.

NOTED:

- This bylaw change would allow sessional lecturers to participate not only in head searches but appointments for new faculty.
- Only those having agreed to participate on council should be included in the pool of faculty members/sessional lecturers allowed to sit on appointments committees.

**FRIENDLY AMENDMENT:** Add Bylaw 44, 3.1.8 revision to mirror Bylaw 40, 4.1.6 revision and change Bylaw 20 sections, 2.1.1, 2.1.2 and 2.1.3 to: "Three or more faculty members/sessional lecturers on **Council** elected by and from all regular faculty members in the AAU **and sessional lecturers on Council**."

## 6 Question Period/Other Business

The Bylaw Review Committee was asked to review the process for electing students to appointments Committee. In large AAUs, electing by and from students in the AAU can be difficult to manage. In other AAUs, electing by and from the students on the AAU Council places too much pressure on the few students on Council.
